1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not a full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

2 External auditor's limited assurance opinion 2023/24

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Section 1, Assertion 1 has been incorrectly completed, the smaller authority has disclosed that it complied with financial management requirements during the year 2023/24, by answering 'Yes' to assertion 1. The council should have ticked 'no' as they did not fully comply with budget monitoring requirements. This is consistent with the Internal Auditor's response to Internal Control Objective D.

Section 1, Assertion 3 has been incorrectly completed, the smaller authority has disclosed that it complied with laws, regulations and proper practices during the year 2023/24, by answering 'Yes' to Section 1, Assertion 3. The council should have ticked 'no' as it did not fully comply with the publication requirements under the Transparency Code. This is consistent with the Internal Auditor's response to Internal Control Objective

Other matters not affecting our opinion which we draw to the attention of the authority:

In the prior year, the smaller authority was exempt from our review, thus we have not reviewed any evidence to support the prior year comparatives on the AGAR.
