Sports Assoc. waiting for latest drawings which must be factual, they cannot compulsory purchase Seven Sites field as it is charitable land. They are still using the illegal entrance despite being told they must cease and there is now video evidence of a huge lorry reversing up onto the pavement, with no supervision, something that happens on a regular basis. This pavement is used by children walking to school; it is felt that Lagan Homes obviously has no concern for the safety of our children and local people. These dangerous acts have been reported on many occasions to Scott Low in enforcement who has shown a poor reaction to this dangerous situation. Police and HSE to be notified of this flagrant disregard for people's safety.
