# 14. LAGAN HOMES UPDATE

Welsh Water has rejected Lagan's plans to connect to the sewerage system. A drainage report still needed, they want to access Amanda Watkins's land to carry out drainage survey but there is confusion as to whether land is owned by A Watkins. Conditions still say a cycleway is required. Sports England have been made aware of the illegal footpath closure and unauthorised access, they have the power to stop any further development until issues are resolved. Apparently houses have been sold and one exchanged, even though conditions have not been met. Kelly Gibbons to be contacted to voice the concerns of the PC. Additionally, it was a condition that no house should be occupied until the 106 health contribution had been paid to the surgery, no payment as of yet has been made, it should have been made at commencement of building. Enforcement is apparently aware of issues but no action appears to be being taken and it seems many u-turns are being made. The PC are appalled that the infrastructure was not put in place before commencement of building, which has led to the dangerous situations that have arisen due to parking on the roadside and the dangerous illegal second entrance and to large lorries turning in the road. Cllr Johnson to report concerns back
