#### 5. <u>COMMUNITY SPEED WATCH</u>

Adnan Ali from the Safer Roads Partnership gave an overview of the Community Speed Watch Scheme. The scheme is run by volunteers with the training and equipment provided. Adnan has identified several locations suitable. A minimum of 6 volunteers is needed and groups must not be less than 3 at any one time. Action is taken when speeds are in excess of +10% + 2mph. Letters from West Mercia Police will be sent, repeated offenders will be visited by a police officer and targeted. Unanimously agreed that Kingstone is put on the waiting list to get involved in the scheme. A parishioner identified himself as willing to lead a local scheme.

#### 6. <u>PUBLIC QUESTION TIME</u>

A parishioner asked that Yew Tree Close gets adopted by Herefordshire Council.

A parishioner pointed out that there are a lot of white lines on the local roads but no actual work being done; additionally the lines are very inconsistent with similar road defects nearby not being marked. Was any quality assurance being carried out? Lengthsman, Cllr. P Wright, stated that the

area had been overseen by a senior Locality Steward recently accounting for some additional white linage and works should be done within 28 days. An independent working party has been set up to look into quality of repairs and they will be reporting back to HC. Utilities are not doing their road repairs to a satisfactory standard, agreed to report this to Cllr. Johnson to be looked into.
