10. SPORTS ASSOCIATION REPORT

Request for asset transfer of parcel of land behind Allpay was made to HC. Matthew Williams has now identified this piece of land as a valuable asset for HC but will possibly offer a lease. Sports Assoc. has managed land long enough to make a legal bid for land. Potentially all funding now has to be overseen by HC. Trees overhanging road but HC will not get them trimmed. There is an historic email from HC stating that piece of land does belong to the Sports Association.

Surface water still a problem, Lagan Homes solution is to encroach on Seven Sites playing fields; this may not be an option.

Historically there has been an increase in crime when travellers have been on this site and there is a very limited police presence in this area. KTPC will object to this via the consultation process.
